ALERT!!!

THE STATE HAS FILED AN APPEAL IN THE DELAWARE SUPREME COURT TO TRY TO OVERTURN OUR SUPERIOR COURT VICTORY. THE STATE, OF COURSE, HAS UNLIMITED FUNDS, RESOURCES AND OUTREACH. WE DON'T! WE CAN ONLY LOOK TO OURSELVES.

IF WE DON'T RAISE SOME SERIOUS MONEY IN THE NEXT FEW WEEKS IN OUR ROUND 2 FUNDRAISING, OUR VICTORY COULD BE IN JEOPARDY AND MEDICARE ADVANTAGE COULD BECOME A REALITY ON JANUARY 1 ST. WHILE THE APPEALMIGHT TEMPORARILY BE DISMISSED, WE KNOW THE STATE WILL APPEAL AGAINAS ALLOWED.
