### My request to Brian Maxwell (chair of the SEBC)

Mr. Chairman,

The SEBC is scheduled to discuss an RFP for the State's prescription drug plan during our March meetings. It appears (from the paperwork distributed at Friday's meeting) that State intends to advertise for a Pharmacy Benefits Manager (PBM).

As you may know, PBMs have come under intense scrutiny and criticism for their questionable practices, including spread pricing and handling of rebates, fees, alternative discounts, and other remuneration received from drug manufacturers. Given that state retirees are currently paying \$265.20 per month for prescription

drug coverage (available on the open market for less than \$100), I believe that we should explore other options before we proceed with discussions about the RFP.

Could we have WTW prepare a presentation for the March 7th meeting explaining the provisions of our current "Silver Script" plan, along with other options such as "reverse auctions," Mark Cuban's "Cost Plus Drugs" plan, Navitus Health Solutions plan, and other comparable plans? An explanation of EGWP and the 340B drug pricing program would also be helpful (especially for us "newcomers").
