# **RISE Update: Important information regarding the RHBA (Retiree Healthcare Benefits Advisory) Subcommittee meetings**

Good evening RISE Delaware:

Here is the RISE position regarding healthcare choice for current and future retirees:

RISE supports Medicfill, or an identical Medicare Supplemental plan, for all current and future State retirees. The recently approved codification by the State legislature of an annual 1% budget contribution puts "Medicfill for All State Retirees" on fiscally sound footing.

In light of the annual 1% budget contribution approved by the State Legislature that addresses retiree healthcare funding issues, RISE supports only the Medicfill plan or an identical Medicare Supplemental plan to what we have now for current and future retirees.

Sections of the message include the need for some RISE members to attend the next three RHBA Subcommittee meetings in person, a sample email message to RHBA Subcommittee members, and a list of subcommittee members with email addresses.

Dear\_\_\_\_:

I am a State of Delaware retiree who is covered by the State of Delaware's Medicfill Medicare Supplemental program. I am asking that the RBHA Subcommittee not include Medicare Advantage as a possible choice for retirees. I am aware of the many problems with Medicare Advantage (MA) plans and I see no reason to burden retirees, who may be unaware of the many pre-authorizations for services and prescriptions required, out-of-network charges, and co-pays that may be incurred when using MA plans. I do not think that you are doing retirees a favor by providing a low-cost option that will be more expensive to them in the long run than purchasing the Medicfill plan. Please vote no to including MA as a possible option for retirees.

## I support providing only the Medicfill plan or an identical Medicare Supplemental plan to what we have now for current and future retirees.

Thank you for your time and attention to this matter which is important to retirees.
